

# NOTICE OF ELECTIONS

STATE OF SOUTH CAROLINA

JASPER COUNTY

The General Election for Federal, State, County, City of Hardeeville and various local offices will be held on Tuesday, November 6, 2018. Any person wishing to vote in this election must register no later than Sunday, October 7, 2018. Voter Registration by mail forms will be accepted if postmarked by Monday, October 8, 2018. In addition to normal business hours, the Jasper County Voter Registration and Election Office will open on Saturday, November 3, 2018 from 9:00am-1:00pm for in-person voting.

Voters will be asked to provide one of the following Photo IDs at their polling place.

- S.C. Driver's License
- ID Card issued by S.C. Department of Motor Vehicles
- S.C. Voter Registration Card with Photo
- Federal Military ID
- U.S. Passport

If you have one of these IDs, you are ready to vote. Voters should remember to bring one of these IDs with them to the polling place. Voters without Photo ID can get one free of charge from the Department of Motor Vehicles or their county voter registration office. Voters who encounter an obstacle to getting a Photo ID should bring their paper voter registration card without a photo with them to their polling place. These voters can then sign an affidavit swearing to their identity and to their obstacle to obtaining a Photo ID and vote a provisional ballot. This ballot will count unless the county board of voter registration and elections has grounds to believe the affidavit is false. At 9:00 a.m. on November 6, the Jasper County Board of Voter Registration and Elections will begin its examination of the absentee ballot return envelopes at the Jasper County Voter Registration and Election Office, located at 1506 Grays Highway, Unit A, Ridgeland, SC 29936 (843)726-7709.

At 8:00am on November 9, the Jasper County Board of Canvassers will hold a hearing to determine the validity of all provisional ballots cast in this election. This hearing will be held at the Senator Clementa Pinckney Government Building, located at 358 Third Avenue, 3<sup>rd</sup> Floor, Council Chambers, Ridgeland, SC 29936.

The following Constitutional Amendment Question will appear on ballots in the November 6, 2018 General Election:

## **Amendment 1**

Must Section 7, Article VI of the Constitution of this State, relating to state constitutional officers, be amended so as to provide that beginning in January 2023, or upon a vacancy in the office of Superintendent of Education after the date of the ratification of the provisions of this paragraph, whichever occurs first, the Superintendent of Education must be appointed by the Governor, with the advice and consent of the Senate; to provide that the appointed

Superintendent of Education shall serve at the pleasure of the Governor; and to require the General Assembly to provide by law for the duties, compensation, and qualifications for the office?

### **Explanation**

A 'Yes' vote will require the Superintendent of Education be appointed by the Governor with the consent of the Senate.

A 'No' vote maintains the current method of electing a Superintendent of Education
