




Community Principles

Jasper County will......

- Protect and foster the rural character of Jasper County that defines our sense of place.
- Take pride in its land through the stewardship of historic, natural, and cultural resources and reduction in litter and blight.
- Support economic development initiatives to provide jobs, education, and training to our community.
- Prioritize the maintenance of existing infrastructure over the development of new infrastructure by guiding growth and development to the places most suitable to serve new development.
- Embrace collaboration with other governmental leaders, education providers, non-governmental organizations, and the community to address community challenges and embrace opportunities, particularly related to education, equity, and leadership.



Urban Transition: Coordination with Hardeeville / Ridgeland

- In the fall of 2023 through the Spring of 2024, Jasper County conducted a five-year update to the County's Comprehensive Plan, with a focus on the land use and community facilities elements.
- During this time, the Euhaw Broad River Planning Area was under a moratorium for new development to allow time for the partial update of the future land use map.
- During this initial phase, Jasper County also conducted a review and prepared updates to the land use regulations, particularly pertaining to the Euhaw Broad River Planning Area.

- Once the County has completed the work with the Euhaw Broad River Planning Area, the County intends to develop a Special Area Plan for the Levy Area. This is a goal that is identified in the Comprehensive Plan.
