1. Call to Order of the Jasper County Council Workshop by Chairman Kemp.

The Clerk's Report of Compliance with the Freedom of Information Act was read as follows: In accordance with South Carolina Code of Laws, 1976, Section 30-4-80(d), as amended, notification of the meeting and the meeting agenda were posted at least 24 hours prior to the meeting on the County Council Building at a publicly accessible place, on the county website, and a copy of the agenda was provided to the local news media and all person's or organizations requesting notification.

• Jasper County Parks and Recreation Master Plan

Mr. Chris Chockley, Ms. Nicole Whiteside and Ms. Catherine Amadon were introduced from the Bolton & Menk Group, and they gave a project introduction. They reviewed Project Phases One thru Four and the Strategic Kickoff. They covered the topics of Inventory, Needs Assessment, Engagement, Survey Results, Goals for Implementation. They reviewed where the County is today noting that the Existing boat landings are heavily used but in need of attention; (2) Underutilized and underinvested community centers and parks; (3) Limited programming impact due to small team; and noted the (4) Opportunity for P&R to engage with adjacent initiatives. After this part of the review, they provided recommendations for the Boat Landings, Parks and Community Centers, Traditional Youth Sports. They discussed these options with the Jasper County Council and provided a wealth of information. For more information on this item please see the Presentation Copy as "Attachment A". 6:00 PM – Meeting:

1. Call the Meeting to Order by Chairman Kemp.

Chairman Kemp called the meeting to order. The Clerk's Report of Compliance with the Freedom of Information Act was read as follows: In accordance with South Carolina Code of Laws, 1976, Section 30-4-80(d), as amended, notification of the meeting and the meeting agenda were posted at least 24 hours prior to the meeting on the County Council Building at a publicly accessible place, on the county website, and a copy of the agenda was provided to the local news media and all person's or organizations requesting notification.

2. Pledge of Allegiance and Invocation:

The Pledge to the Flag was given and the Invocation was given by Councilman Rowell.

3. Approval of the Regular Agenda:

Chairman Kemp noted that he would like to amend the regular agenda to add to Executive Session Item # 2 Baske vs Jasper County.

PRESENTATION

3. Michael Bell BJWSA Board Member, Chairman of the BJWSA Under Served Committee

Chairman Kemp introduced Mr. Michael Bell of the BJWSA Board Member, Chairman of the BJWSA Under Served Committee. Mr. Bell thanked Chairman Kemp for inviting him to speak. He noted that he had been a long-time member of the BJWSA and had served as the Chairman on numerous occasions. He provided some background information on the BJWSA and mentioned that the BJWSA had been around since 1954. He noted that it had started out as just a water entity as a nonprofit public designed to provide water for the area. In 1969 they expanded to provide sewer collection and disposal. In 1971 Jasper County Water and Sewer Authority was created. In 1983 they merged with Beaufort and became the Beaufort Jasper Water Sewer Authority. They have 11 members, and four members represent Jasper County, Hardeeville and Ridgeland. He noted that he had been invited to come to the council meeting to discuss a committee they call the Ad Hoc on underserved and the committee was started in 2022 with the idea that some of their 67,000 who drink their water and only 48,000 of them have sewers. He noted that this was about 19,000 that are without the ability to have sewer in their area and are primarily on septic systems.

He noted that septic tanks work good in good soil, but not so well in areas where you have marshes, a highwater table, or when they are not maintained. He noted that DHEC recommends maintaining the septic system every 3 years. He noted that septic systems are an issue when the drain field is wet. He provided some handouts for Council and showed some photos of situations where a yard was covered with water, and they were on a septic system. In 2021 they started to take the lead to begin to work and find pockets in this area where septic tanks are failing and see what they could do because they recognized that not everyone can afford to maintain those systems, so they don't. When this happens, those systems become contaminated and leak into the soil, and the marsh and the leaks cause issues. He said the committee met as an Ad Hoc Committee and formed a partnership and created a recommendation for the full board. He said the full board

bought in to what they were suggesting which was the Authority take the lad, collaborate support and advocate for underperforming well and septic systems. They then recommended and the board approved that they create a Governmental Affairs and Strategic Planning Position. That position would be charged with coordinating and working with outside stakeholder groups and identify and secure funding. Then they created a Conceptual Policy to provide to those communities that they referenced. Then they were tasked with developing a Pilot Project to support this committee and this recommendation which was adopted. He showed some of the properties on the screen and the issues they were facing. He introduced the Levy Area Representative Ms. Bond to the Council.

Mr. Lee brought Mr. Charlie Stone, Director of Governmental Affairs, to the BJWSA up to the podium. He noted that he had been with BJWSA for 15 months now and that he had the good fortune of working on this underserved initiative. He discussed how they were working with this situation and the initiative and noted they are focusing on water and sewer needs. He noted that their Pilot project was tasked to figure out how to improve those areas in need. He noted that they are focused on addressing public health issues and prioritizing the environment. He discussed the Beaufort Alljoy Community Project, the old Bailey's Project and the Levy Project they are working on with Heather Rath. He discussed some of the projects that they are working on. He noted that their job was to bring the obstacles of entry down for the residents and connect as many people as possible.

Chairman Kemp recognized Bill Fishburne with the Town of Ridgeland; Sheriff Malphrus and Mayor Harry Williams of the City of Hardeeville.

PUBLIC HEARING ONLY

4. Public Hearing Only to receive comments on an Ordinance to amend Jasper County Zoning Ordinance, Article 5, Zoning District Regulations, to add two (2) new primary zoning districts; Rural Preservation – 10 (RP10) and Village Commercial (VC), one (1) new overlay district, Euhaw Overlay District (EOD); amend Article 6, Use Regulations, to add uses for the RP-10 and VC zoning districts; amend Article 7, Primary Districts, to add lot size, lot width, and setback requirements for RP-10 and VC zoning districts, amend minimum lot width requirements in other zoning districts, and amend riparian buffer requirements; amend Article 8, Special Purpose Districts, to add a new section, Article 8:9 Euhaw Overlay District, which includes design standards and requirements for the Euhaw Overlay District (EOD); amend Article 11, Conditional Use Review and Regulations; to add conditions for certain uses; amend Article 15, Sign Regulations to add standards for the RP-10 and VC zoning districts; amend Article 22, Rural Small Lot Subdivision Standards, to provide alternative standards for subdivisions of family owned lands; and amend the Jasper County Official Zoning Map to re-zone some properties within the Euhaw Broad River Planning Area to the Rural Preservation - 10 Zoning District and the Village Commercial Zoning District.

Ms. Wagner was present to discuss this request. She noted that a workshop was held on October 21st, at the City Council meeting and she discussed Jasper's Journey. In 2023 she noted that Jasper County had hired a consultant to work with them. She also noted that a temporary moratorium had been enacted. She noted that staff had prepared zoning text amendments that would assist the Growth Management Plan.

The public hearing was opened, and the following speakers spoke on this matter:
Kate Schaefer discussed thoughtful planning and RP10 and the Euhaw Overlay District.
Ashley Rhoes discussed the Euhaw Overlay District and provided her thoughts on this project.

Wayne Gallahan discussed the Tax Sale.

Cathy Malphrus discussed her views on this item and the family's heritage on the property.

Smittie Cooler discussed Euhaw Overlay District and how to preserve it.

An unnamed resident thanked them for protecting the Euhaw District and the conservation of the Port Royal Sound Watershed.

Patrica Hicks-Dupont discussed annexation and her thoughts on the subject,

There were no other comments, so the public hearing was closed.

David Tedder – Public Hearing and consideration of the 3rd Reading of Ordinance #0-2025-11 to amend the Jasper County Code of Ordinances by repealing Chapter 28, *Utilities*, Articles II through IV in their entirety and replacing them with a new Article II. (1st reading 04.07.2025; 2nd reading 04.21.2025)

Mr. Tedder was present to review, address and discuss the request for the consideration of the 3rd Reading of Ordinance #O-2025-11 to amend the Jasper County Code of Ordinances by repealing Chapter 28, *Utilities*, Articles II through IV in their entirety and replacing them with a new Article II. The public hearing was opened but there were no comments, and the public hearing was closed.

10. Lisa Wagner – Consideration of 1st Reading of an Ordinance to Amend the Jasper County Code of Ordinances, Chapter 25 – Article III, Naming and Addressing of Roads, Section 123 Definitions, Section 126 New Road Names, and Section 127 Renaming Roads so as to make minor revisions for clarification purposes and to provide consistency with state law.

Ms. Wagner was present to review, address and discuss the request for the consideration of the 1st Reading of an Ordinance to Amend the Jasper County Code of Ordinances, Chapter 25 – Article III, Naming and Addressing of Roads, Section 123 Definitions, Section 126 New Road Names, and Section 127 Renaming Roads so as to make minor revisions for clarification purposes and to provide consistency with state law.

Ms. Wagner noted that the intent of this Ordinance is to amend the Jasper County Code of Ordinances, Chapter 25, Article III, Section 123 (Definitions), Section 126 (New Road Names), and Section 127 (Renaming Roads). The purpose of this amendment is to provide clarity and consistency with the state law as it relates to the naming of roads. She noted that Title 6, Chapter 29, Section 1200 of the SC Code of Laws delegates road naming authority to the local Planning Commission. In accordance with the Jasper County Code of Ordinances, the address program administrator is responsible for the interpretation and administration of Jasper County's Naming and Addressing of Roads Ordinance since they are the personnel that keeps inventory of the road names and addressing data.

The specific changes are very minor in nature and were outlined as follows:

• Section 123 – Definitions: This section includes adding language to the definition of "Concurrence" to make clear that the Planning Commission only concurs if they fail to take action after two meetings once the road name petition has been submitted to them for review. Language is added to "County Roads," which makes

reference to the revised Master List of County Roads dated February 2017. The definition of "Private Roads," includes replacing the clerk of courts office with the office of register of deeds.

- Section 126 New Road Names: This section restructures the first sentence in paragraph #8, under Section 25-126 to remove "mobile home roads" and the requirement for three (3) homes to be located on the new road. New roads in subdivisions or Chapter 25 Article III Naming and Addressing of Road 2 of 2 developments should be named prior to any structures being built or accessed by a new road.
- Section 127 Renaming Roads: This section changes the method of initiating road name changes from three methods to four methods to include the address program administrator. Language is added to public notice requirements to include notice to be posted on the county's website or social media page when a road name change is requested. The last paragraph in Section 25-127, replaces the office of the register of mesne conveyance or clerk of court with the office of the register of deeds.

Ms. Wagner mentioned that the Planning Commission reviewed this ordinance amendment at their April 15, 2025, Meeting and recommends approval of the proposed amendment as outlined in the Ordinance.

Ms. Burgess was present to review, address and discuss the request for consideration of proposal recommendation for armed security services for the Jasper County Judicial Building, 967 W. Adams Street, Ridgeland, South Carolina and to authorize the County Administrator or his designee to execute all documents necessary to obtain the services. She noted that this request was for armed security for Judicial Building for Judge Lee. Ms. Burgess noted that Jasper County advertised for sealed proposals for armed security services at the Jasper County Judicial Building, 967 W. Adams Street, Ridgeland, SC. Proposals were due at 3 PM on April 9, 2025. She mentioned that the County received three proposals and the committee consisting of Chief

Magistrate Lee, Judge Badgett, and Kimberly Burgess, Director of Administrative Services, reviewed the proposals. She said that Judge Lee and Director Burgess interviewed two of the three proposers. The committee determined that while both proposers had excellent credentials and a similar approach to the provision of security services, Noble Shields Private Security personnel have experience providing security to the Judicial Building.

She noted that staff requested that the Council accept and approve the proposal offered by Noble Shields Private Security to provide armed security services at the Jasper County Judicial Building on 967 W. Adams Street, Ridgeland, SC and to authorize the County Administrator or his designee to execute the necessary documents to execute the contract.

Ms. Burgess was present to review, address and discuss the request for consideration of the 1st Reading of an ordinance of Jasper County Council to Amend Jasper County Ordinance No. O-2024-13 For Fiscal Year 2025 Jasper County Budget to Provide for Amendments to the Budget; And to Provide for Effective Date of this Ordinance. Ms. Burgess noted that this budget amendment was for the FY2024-2025 budget and amends the original ordinance # O-2024-12 approved on June 3, 2024. She noted that there had been an increase of \$2,989,000.00 in both the revenues and expenditures. She reviewed some of the amendments to the different revenue and expenditure line items and explained how that worked. She noted that a lot of the items were amended to actual. She noted that the Airport Officer reimbursement was decreased (line # 57-1609) for the Sheriff Deputy for the Airport since the Deputy was no longer utilized there. She noted that this was accounted for in both the revenues and the expenditures. She discussed transfers in (money coming from another fund) in the amount of 1 million dollars approved by Council on Resolution # R-2024-36 noting that this money came in from the Economic Development Fund and was paid out to Technical College of the Lowcountry (TCL). She mentioned some other items included such as the cash carry forward, the two storms which incurred disaster expenses that were unbudgeted, the Detention Center Fire expenses that were not budgeted, additional funds requested by the Solicitor, repairs to the Levy Fire Station, architectural fees to the Coosawhatchie Fire Station, and other items. Council gave their view on what they would like to see on information such as this and for the upcoming readings.

She noted that during the month of June, a second meeting would be held on Monday, June 16, 2025, and during the month of December, a second meeting would be held on Monday, December 15, 2025. Staff recommended approval of the Revised 2025 County Council Meeting Calendar. There was no motion made on this item, but all Councilmembers unanimously approved this item.








HOW LONG HAVE YOU LIVED IN JASPER COUNTY? 176 Total Responses





- Invest in the required maintenance and fix what you already have for all landings
- Acquire Becks and New River Landings

What Next?



Recommendation #2 – Parks and Community Centers

 Upon addressing boat landings and the necessary land conveyance, repairs and maintenance, focus on updating and enhancing the existing parks and community centers throughout the county.

Recommendation #3 – Traditional Youth Sports

 Consider enhancing facility and programming opportunities for traditional youth sports including baseball, basketball, football and soccer.

1. Call to Order of the Jasper County Council Workshop by Chairman Kemp.

The Clerk's Report of Compliance with the Freedom of Information Act was read as follows: In accordance with South Carolina Code of Laws, 1976, Section 30-4-80(d), as amended, notification of the meeting and the meeting agenda were posted at least 24 hours prior to the meeting on the County Council Building at a publicly accessible place, on the county website, and a copy of the agenda was provided to the local news media and all person's or organizations requesting notification.

Pledge to the Flag and Invocation

The Pledge to the Flag was given and the Invocation was given by Councilman Rowell.

Approval of Agenda

Motion to approve the agenda: Councilman VanGeison

Vote: Unanimous The motion passed.

FY2026 Budget

Mr. Fulghum provided a recap of a few additional workshops that were planned. He passed out a copy of the 2020 Clemson Study Impact Analysis Report (which was a follow up to the 2006 Clemson Study). He also noted that this was a unique budget this year and discussed the reasons why it was unique to Jasper County. He then passed out the current schedule of council workshops. He noted that there was the workshop today and a one-hour workshop that was planned on 5/19 on the budget. He noted that they were planning to bring a budget to them on May 19th. He mentioned that proposers for funding requests, from the appointed Committee of Councilman Rowell and Councilman Arzillo Would be presented so Council could decide when and how they wanted to meet with the presenters.

Ms. Burgess Passed out the spreadsheet to council on what the presenters were requesting as well as what they have received last year from Jasper County. Mr. Fulghum reviewed where they currently were on the budget and talked about reallocation of the millage rates. He noted that Mr. Lawrence Flynn was there to discuss the allocation of the millage with Council. It was also noted that council had a number of Newly Appointed Constitutional Elected Officials that they may want to bring in and go over the request that they were making for the budget. Chairman Kemp noted that on the upcoming workshop listing that several of the topics needed to be postponed until the budget was finished.

Ms. Burgess noted that they had received all the Departments requests and noted that this was the 4th column over from the right under 2026 Department Requests. Ms. Burgess discussed the current value of a mill and the value of the mill from last year. She discussed the upcoming Fiscal Year in regard to both revenues and expenditures. She reviewed the information for the FY2025/2026 budget year and discussed the financial aspects of the budget.

Mr. Lawrence Flynn of the Pope Flynn Group discussed his presentation (Attachment "A") with Council covering the Bonds, Tax Millage and Plan of Finance. He discussed and reviewed the topics of:

General Obligation Debt:

- General obligation debt is defined to mean "any indebtedness which shall be secured in whole or in part by a pledge of its full faith, credit and taxing power."
 - May be issued for any corporate purpose.
 - General obligation bonds are typically used for "brick and mortar" projects, particularly where the project does not produce a stream of revenues to support revenue bonds.
 - General obligation bonds are typically repaid from *ad valorem* property taxes, which are exempt from limitations of Act 388.
 - Unless approved by referendum, all general obligation debt is subject to the County's debt limit: 8% of assessed value of all taxable property.



Limitations on Property Taxes:

- Act 388 (S.C. Code 6-1-320)
 - Limits ability of local governments to increase operating millage rates to the level of CPI + population growth
 - Allows an additional "three-year lookback" to use millage increases that were allowed but not used in prior years
- Debt Service Millage
 - Imposed to pay debt service on general obligation bonds that have been issued
 - Only imposed up to amount needed to pay annual debt service
 - Inadvisable use such millage to make payments on debt other than general obligation bonds

Description: The purpose of this Ordinance is to correct a scrivener's error. On June 2, 2025, the Council approved 3rd Reading of an Ordinance (O-2025-12) to amend Chapter 25 of the Jasper County Code of Ordinances, Article III, *Naming and Addressing of Roads*. Staff discovered that two minor errors were made when Ordinance 2025-12 was originally drafted.

Specifically, under Definitions, the definition of *County Road* was erroneously copied from an older version of the Addressing and Road Naming Ordinance, and a portion of the last sentence under *Private Road*, was inadvertently omitted.

While this Ordinance will make changes to correct a scrivener's error, it does not make any changes to the purpose and intent of the original amendment to the Addressing and Road Naming Ordinance that was approved by Council on June 2, 2025.

Analysis: Prior to the most recent amendment (June 2, 2025) to the Addressing and Road Naming Ordinance, Section 123 under Definitions, (1) *County Road* and (2) *Private Road* was defined as:

- (1) County Road: As defined in Section 25-41 hereinabove.

 The Master List of county roads as maintained by the department of public works as set forth in Section 25-41(a)(1) are made part of this article as though copied herein. Any revision to the list or the map also shall be incorporated herein and made a part of this article.
- (2) *Private Road:* No road shall be designated as a private road unless: In a new development, such proposed road is defined as such by action of the county planning commission upon its satisfaction as to the construction and perpetual maintenance

of such road; (see appendix B, including sections 3.10 and 7.3 of appendix B of the Jasper County Code of Ordinances as to perpetual maintenance);

The Ordinance that was presented to County Council defined *County Road* and Private Road as:

(1) County Road: Any road currently maintained under the county road maintenance system and any new road to be constructed within the jurisdiction of the county, and dedicated for maintenance to the county, which is in excess of 100 feet in length and accesses, or presupposes to access, two or more parcels of land under different ownership, unless such road is a part of the state, or federal system of highways or by definition, a private road.

The master list of county roads as maintained by the department of public works, and the mapping of said roads compiled by the Lowcountry Council of Governments at the direction of the county and dated June 1, 1998, and the revised Master List of County Roads dated February 2017 are made part of this article as though copied herein. Any revision to the list or the map also shall be incorporated herein and made a part of this article. (This was the definition prior to the 2018 amendment of the Addressing and Road Naming Ordinance and was erroneously copied into the most recent ordinance)

(2) *Private Road:* No road shall be designated as a private road unless: In a new development, such proposed road is defined as such by action of the county planning commission upon its satisfaction as to the construction and perpetual maintenance of such road; (reference to appendix B and sections 3.10 and 7.3 listed in the parenthesis was inadvertently omitted)

The proposed ordinance will define County Road and Private Road as shown on page 1 of this staff report, which is the same definition prior to the adoption of the June 2, 2025 Ordinance (O-2025-12).

Recommendation: Staff recommends approval of the Ordinance to ensure that the Road Naming Ordinance is correct, which will also ensure the Ordinance is updated correctly in the County's Code of Ordinances and refelected as such in the Municode.

NOW THEREFORE, BE IT ORDAINED, by the Jasper County Council duly assembled and by the authority of same:

- 1. Article III of Chapter 25, (Naming and Addressing of Roads), Section 25-123, (Definitions) of the Code of Ordinances, is amended to read as follows:
 - Sec. 25-123. Definitions.
- (1) *County road:* As defined in section 25-41 hereinabove. The master of list of county roads as maintained by the department of public works as set forth in section 25-41(a)(1), are made part of this article as though copied herein. Any

revision to the list or the map also shall be incorporated herein and made a part of this article.

(2) Private road: No road shall be designated as a private road, unless:

In a new development, such proposed road is defined as such by action of the county planning commission upon its satisfaction as to the construction and perpetual maintenance of such road (see appendix B, including sections 3.10 and 7.3 of appendix B of the Jasper County Code of Ordinances as to perpetual maintenance of such road); or

2. This ordinance shall take effect	upon approval by Council.

Description: This is a zoning map amendment request to have two properties designated as Community Commercial. The subject properties consist of 4.90 acres and 4.0 acres and are located along Speedway Boulevard. Both properties are currently split-zoned Residential and Community Commercial. Both properties are vacant undeveloped. The applicant would like to re-zone the properties to allow the properties to be used as commercial although a specific use has not been identified.

Analysis: The Zoning Map Amendment application and request are reviewed by considering the following factors:

- Comprehensive Plan: According to the 2018 Jasper County Comprehensive Plan, the Future Land Use Map identifies this area as "Urban Transition," which are pockets of unincorporated Jasper County that are partially or entirely surrounded by the municipality. For these areas that experience new development or redevelopment, consideration should be given to working with the adjacent municipality for annexation.
- *Adjacent Zoning*: The adjacent parcels are zoned Community Commercial, Residential, and Rural Preservation. The 4 acre property identified by tax #039-00-01-041 is adjacent to the City of Hardeeville. This portion of Speedway Boulevard is located within the Gateway Corridor Overlay District.
- Adjacent Land Use: Adjacent land uses are commercial development, a church, and the former Pin Tail Golf Course.

• *Traffic and Access*: The subject properties are accessed by Speedway Boulevard and has frontage along Purrysburg Road. Speedway Boulevard is a four-lane state maintained road classified as a major thoroughfare. Purrysburg Road is both paved and dirt and is maintained by SCDOT, which is a limited local road.

Planning Commission Recommendation: The Planning Commission reviewed this application at their June 10, 2025 Planning Commission Meeting and recommends approval of the request to have both properties designated as Community Commercial.



AN ORDINANCE OF JASPER COUNTY COUNCIL

An Ordinance Amending the Business License Ordinance of the County of Jasper to Update the Class Schedule as Required by Act 176 of 2020.

WHEREAS, Jasper County (the "County") is authorized by S.C. Code Section 5-7-30 and Title 6, Chapter 1, Article 3 to impose a business license tax on gross income;

WHEREAS, by Act No. 176 of 2020, known as the South Carolina Business License Tax Standardization Act and codified at S.C. Code Sections 6-1-400 to -420 (the "<u>Standardization Act</u>"), the South Carolina General Assembly imposed additional requirements and conditions on the administration of business license taxes;

WHEREAS, the Standardization Act requires that by December thirty-first of every odd year, each municipality levying a business license tax must adopt, by ordinance, the latest Standardized Business License Class Schedule as recommended by the Municipal Association of South Carolina (the "<u>Association</u>") and adopted by the Director of the Revenue and Fiscal Affairs Office;

WHEREAS, following the enactment of the Standardization Act, the Municipality enacted Ordinance No. 2021-26 on December 6, 2021, in order to comply with the requirements of the Standardization Act (the "<u>Current Business License Ordinance</u>");

WHEREAS, in compliance with the Standardization Act, the Municipality enacted Ordinance No. O-2023-19 on December 18, 2023;

WHEREAS, the Jasper County Council (the "<u>Council</u>") now wishes to amend the Current Business License Ordinance to adopt the latest Standardized Business License Class Schedule, as required by the Standardization Act;

NOW, THEREFORE, BE IT ORDAINED by the Jasper County Council, as follows:

SECTION 1. Amendments to Appendix B. Appendix B to the Current Business License Ordinance, the "Business License Class Schedule," is hereby amended as follows:

- (a) Classes 1 through 8 in Appendix B to the Current Business License Ordinance, the "Business License Class Schedule," are hereby amended and restated as set forth on the attached Exhibit A.
- (b) Class 9 in Appendix B to the Current Business License Ordinance, the "Business License Class Schedule," shall remain in full force and effect as set forth in the Current Business License Ordinance.

SECTION 2. Repeal, Effective Date. All ordinances in conflict with this ordinance are hereby repealed. This ordinance shall be effective with respect to the business license year beginning on May 1, 2026.

SECTION 4. This Ordinance shall take effect upon approval by Council.

Subject: Year Two Funding Request for OD Map Administration - New Life Center

Background

In 2026, Jasper County will begin year two of a **two-year agreement with the New Life**Center to administer OD Map for the County, a system designed to track overdoses and track response efforts across multiple agencies in Jasper County. This program strengthens coordination among law enforcement, emergency medical services, healthcare providers, and community-based organizations and is meant to give a real picture of the overdose situation in Jasper County.

While the New Life Center agreement is structured as a two-year contract, **funding is** requested and approved annually through the South Carolina Opioid Recovery Fund Board (SCORF).

Funding Request

Jasper County, is requesting the use of \$62,000 from the Jasper County SCORF allocation to be applied to the SCORF Board in October 2025, with funds available beginning January 2026 to support year two of the New Life Center contract.

Motion & Action Requested

We ask for a motion to direct staff and consultants to apply for \$62,000 in funding to the SCORF Board in October 2025 for year two of the OD Map administration contract with the New Life Center.

Education Consultant Update

The County's contract with the **Education Consultant** has now kicked off. This effort provides critical education and outreach components to complement the overdose mapping program. A detailed update on progress will be provided to Council by **November 2025**.

MEMORANDUM OF UNDERSTANDING BETWEEN New Life Center AND Jasper County, South Carolina

Subject: ODMAP Management Collaboration

WHEREAS, Jasper County, South Carolina, recognizes the pressing need to address the opioid crisis within its jurisdiction, and

WHEREAS, New Life Center is an established organization with expertise in addiction support and recovery services, and

WHEREAS, Jasper County is committed to leveraging data-driven approaches to combat the opioid crisis effectively, and

WHEREAS, Jasper County recognizes the deficiencies of current data into the ODMAP tool and is committed to improvement,

NOW, THEREFORE, in recognition of their shared goals and mutual desire to collaborate on opioid data management using the Overdose Detection Mapping Application Program (ODMAP), Jasper County, South Carolina, and New Life Center hereby enter into this Memorandum of Understanding (MOU) under the following terms and conditions:

1. Purpose and Scope:

1.1. The primary objective of this MOU is to establish a collaborative partnership for the management and utilization of ODMAP data to enhance opioid overdose response and intervention efforts within Jasper County.

2. Responsibilities:

- 2.1. Jasper County agrees to provide access to relevant overdose data, as permitted by applicable laws and regulations.
- 2.2. New Life Center will oversee the management and analysis of ODMAP data, maintain the ODMAP for Jasper County, and ensure data confidentiality and security.
- 2.3. Both parties will collaborate to identify trends, hotspots, and emerging issues related to opioid overdoses within Jasper County in accordance with the Phase 1 Jasper County Opioid Management Funds Use Plan attached hereto as Exhibit "1", utilizing funds provided by Jasper County as set forth in the New Life Center Jasper County Proposed Annual Budget -1st Year attached hereto as Exhibit "2".
- 2.4. New Life Center will regularly share ODMAP data, reports, and analysis with Jasper County, providing insights for informed decision-making.

2.5. Jasper County, SC will evaluate this agreement annually to ensure scope is being accomplished.

3. Data Confidentiality:

3.1. Both parties acknowledge the sensitivity of ODMAP data and commit to ensuring its confidentiality, complying with all relevant laws and regulations, including but not limited to data sharing agreements and HIPAA requirements.

4. Term and Termination:

- 4.1. This MOU shall be effective for a period of two years from the date of signature.
- 4.2. This MOU shall be effective upon signing and will continue until either party provides a written notice of termination, with a minimum 30-day notice.
- 4.3 Notwithstanding section 4.1 above, should the budget for year two of this Agreement be larger than the amounts being allocated under Exhibit "2" hereto, Jasper County reserves the right to terminate this MOU.

5. Amendment and Modification:

5.1. This MOU may be amended or modified by mutual written agreement of both parties.

6. Governing Law:

6.1. This MOU shall be governed by and construed in accordance with the laws of the state of South Carolina.

7. Entire Agreement:

7.1. This MOU constitutes the entire agreement between Jasper County and New Life Center regarding the subject matter herein.



- Include questions in surveys that capture neighborhood-specific changes in awareness.
- Seek feedback from community members through localized focus groups.

Media Reach - Measurement

- Monitor the reach and engagement of campaign content in each neighborhood separately.
- Evaluate the effectiveness of radio messaging by analyzing audience response in targeted areas.

Incident Reports

- Monitoring by New Life Center with OD MAP
- Evaluate changes in opioid-related incidents in targeted areas to measure impact.

Attendance - Measurement

- Assess neighborhood-specific attendance and engagement in events, workshops, and support groups.
