Meeting Minutes

- VII. **OLD BUSINESS:**
 - A. **MALZONE M. RUSSELL - PRESENTATION OF COUNTY WIDE ROAD PROJECT**
Mr. Russell distributed to the committee a "Prioritized Listing" of every road in the County that SCDOT owns. Mr. Russell highlighted/ranked the top fourteen (14) roads need resurfacing. Mr. Russell explained the nomenclature of the

listing and how it is used to determine the worst roads needing work. He reviewed the roads that are receiving Federal Funding. He also informed the committee that an "Assessment" of the county roads condition is done every two (2) years. Mr. Rudy Smith, Vice-Chairman, wanted to know the progress of the roads already funded. Mr. Russell informed Mr. Smith to request a "Continuous Update" on the progress of the roads already funded from Mr. Michael Fulmer, Lowcountry Program Director. The committee members requested to do a ride-a-long with Mr. Russell so they can see the condition of the roads themselves.

B. DALE TERRY – UPDATE ON COUNTY ROAD ROCKING: *Mr. Terry informed the committee that he is very please, things are going well. They are still receiving rocks and still doing some touch-ups on the Old House and Bolden Hall roads. Mr. Smith asked Mr. Terry to check out the condition at Saulsberry Landing (check out the rip-rap). Mr. Freddie Brantley wanted to know how they determine what road needs to be rocked. Mr. Terry further explained.*

C. DALE TERRY – UPDATE ON TOOMERVILLE RECYCLING CENTER: *Mr. Terry stated the project is progressing, and he spoke with Ms. Kattie Woodruff, in the Planning Development Department about permits for packers.*
