Meeting Minutes

COMMITTEE MEMBERS PRESENT: *Chairman Rudy Smith, Vice-Chairman Alex Flint, Weldon Wall, Freddie L. Brantley, and Leo Gaston were all present at the meeting.*

I. CALL TO ORDER: *Meeting called to order at 3:00 p.m. by Chairman Rudy Smith.*

II. INVOCATION: *Led by Mr. Alex Flint*

III. PLEDGE OF ALLEGIANCE: *Everyone in attendance*

IV. APPROVAL OF THE MINUTES: *There was no meeting in April 2020, therefore, there was no minutes to approve.*

V. PUBLIC COMMENTS: *There were no Public comments.*

VI. NEW BUSINESS:

ANDY FULGHUM: **REQUEST FOR FUNDS FOR HIGHWAY 278 ROAD WIDEN PROJECT IN THE AMOUNT OF \$302,500.00:** *Mr. Andrew Fulghum, Jasper County Administrator, made a request to the Committee to approved \$302,500.00, for Professional Engineering Services, for US Highway 278 Corridor Widening, Stormwater Drainage Improvements and Malphrus Road Intersection Realignment in the Town of Ridgeland, Jasper County, South Carolina, Proposal No.: P18011-D Revised.*

After discussion on the matter, Vice-Chairman Alex Flint made a motion to approved funding in the amount of \$302,500.00, for Professional Engineering Services, the motion

was seconded by Mr. Weldon Wall. The Committee voted unanimously YES, and the motion passed and was approved.

MALZONE M. RUSSELL- REQUEST CONSIDERATION OF FUNDING FOR PRESCHOOL ROAD (WAGON BRANCH AREA): *Mr. Russell asked the Committee to consider funding a resurfacing project of Secondary Road 110, (approximately 1.1 miles). Mr. Russell will present cost estimate figures at the next month's meeting.*

VII. OLD BUSINESS

ANDY FULGHUM – UPDATE ON NATHANIEL WRIGHT'S DRAINAGE PROBLEM PROJECT: *Mr. Andrew Fulghum, Jasper County Administrator, said he have spoken with the engineer consultant and the study would cost approximately \$20,000.00. Mr. Dale Terry, Public Works Supervisor, also spoke on the matter. Mr. Terry said he have received approval from other surrounding residents in the area to do further drainage cleaning and clearing. Mr. Fulghum said he will provide the proposal for the study at the next meeting.*

MALZONE M. RUSSELL- REQUEST FUNDING FOR HIGHWAY S-27-151 (ROSELAND AREA): *Mr. Russell presented to the Committee a Request for Programming for, Resurfacing of Secondary 151 (Deloss Point Road), in the amount of \$464,800.00. Vice-Chairman Alex Flint made a motion to approve the request, motion seconded by Mr. Leo Gaston. The Committee voted unanimously YES, and the motion passed and was approved.*

DALE TERRY – REQUEST FUNDING FOR RESURFACING OF SHINGLER AVENUE (COUNTY ROAD): *Mr. Dale Terry made a request to the committee to approve funding for the repaving of Shingler Avenue, off highway 170, in the amount of \$75,000.00. Vice-Chairman Alex Flint made a motion to approve funding in the amount of (\$75,000), for the resurfacing of Shingler Avenue, motion seconded by Mr. Leo Gaston. The Committee voted unanimously YES, and the motion passed and was approved.*
