Meeting Minutes

COMMITTEE MEMBERS PRESENT: *Chairman Rudy Smith, Vice-Chairman Alex Flint, Weldon Wall, Freddie L. Brantley, and Leo Gaston Jr. were in attendance.*

I. CALL TO ORDER: *Meeting called to order at 3:00 p.m. by Chairman Rudy Smith.*

II. INVOCATION: *Led by Mr. Alex Flint*

III. PLEDGE OF ALLEGIANCE: *Led by Chairman Smith.*

IV. APPROVAL OF THE MINUTES: *Mr. Alex Flint made the motion for the approval of the minutes, and Mr. Leo Gaston second it.*

V. PUBLIC COMMENTS: *There were no Public Comments.*

VI. NEW BUSINESS:

MR. MALZONE RUSSELL: *Mr. Russell presented a programming request to consider funding for Moore Street in Hardeeville, SC., which will be a replacement for S-27(223 And 224). Mr. Russell stated that it is near John Smith (S 338). Mr. Chairman responded by stating, the committee will need 30 days to go out to check the road. Therefore, the request will need to be placed back on the Agenda, for consideration at the next meeting.*

VII. NEW BUSINESS: MR. MALZONE RUSSELL: *Requested defunding for S-27(223 and 224). These two roads were a part of a prior submittal package, however, is being funded by SCDOT in their annual resurfacing package. Therefore, is asking the*

committee to cancel their submittal for those two roads, and use those funds to cover the cost of Moore Street. Therefore, Mr. Russell's request is for the Committee to consider defunding S-27 (223 and 224). Mr. chairman asked for a motion to defund S-27(223 and 224). Mr. Flint made the motion to defund S-27(223 and 224). Mr. Leo Gaston second the motion.

Ms. Arnesha Fair gave a presentation for information purposes only. Beaufort County maintains a section of SC- 170 near Argent Square, and they are trying to have it placed on their 2021 Preservation Project List, however if it does not get funding to make the 2021 list, then it will be placed on their 2022 list. The committee accepted the update as information.

Mr. Chairman stated that he spoke with Bryce Construction, the contractor for the Hwy #3 project, and asked him to give that road priority because he has been getting complaints on that road. He also stated that he spoke with Mr. Jason Farrell, an area supervisor, who said the work should get started before the end of the year, that he could not give an exact date, but he will do all he can to get the project started by September.

VIII. ADJOURN: *There being no further business to discuss, Mr. Chairman asked for a motion for an adjournment of the meeting. Mr. Leo Gaston made the motion, and Mr. Freddie Brantley second it. The meeting was adjourned.*
